Proposal #1 Down to Earth Tree Care: Very detailed and professional proposal. Comes highly recommended and has good references. Proposal costs are broken down, but adding it up it would be \$4,500.00/day + \$150/load for disposal. Estimate of costs would be over \$15,000.00+ for the three days of chipping. Proposal #2 Simon's Tree Service: Proposal was bare bones and to the point. Comes highly recommended, has good references, and a good reputation in the community. Proposal costs were a flat \$4,000.00/day. Costs would be \$12,000.00 for the three days of chipping. Simon is local and familiar with the area. The project was budgeted at \$15,000.00. Simon's Tree Service is the only one that would come in under the amount budgeted.
